Galería Artelibre in collaboration with the “Fundació de les Arts i els Artistes” announces the X ModPortrait, a painting contest in the Portrait Mode, endowed with a First Prize of 10,000 euros, a Special Drawing Prize of 4,000 euros, 2 one-week-workshops at the BAA (Barcelona Academy of Art), a prize of 1,000 euros for the purchase of material at ARTEMIRANDA and the Special Portrait Award of 500 euros sponsored by Galeria artelibre.

Galería Artelibre and the “Fundació de les Arts i els Artistes” seek to promote and disseminate Figurative Art. The main task is to encourage artistic initiatives and to sponsor artists.

RULES

- 1.- Participation is open to all artists.
- 2.- Several works are accepted per author. The artworks must be original and the exclusive property of the artist.
- 3.- The exclusive theme is the PORTRAIT, always in the Figurative Art mode. Technical skill and originality of the subject will be valued.

4.- Presentation

The minimum dimensions are 40x40 cm and the maximum dimensions are 150x150 cm. Dimensions that are less than 40 cm or more than 150 cm will be accepted provided that the sum of width by height is not less than 80 cm or more than 300 cm.

The work must be presented without framing or, alternatively, with a simple strip. Works protected with glass are not allowed (if necessary, please use methacrylate).

5.- How to participate

5.1 Registration

Open from October 1st to December 31st 2023 (non-extendable), solely and exclusively through the websites: www.artelibre.net and www.modportrait.net.

- Fill in the form with complete artist and work data.
- Attach the image of the work (file dimensions min. 1.5 and max. 6 megabytes)
- Make the payment of €48 as registration for each of the works.
- You can submit as many works as you wish, by filling in one form per work.

5.2 Documentation

Once the form, the image and the payment by PayPal have been sent, you will receive a confirmation e-mail. Please check that the information provided is correct.

5.3 Assessment

An internal jury will make a first pre-selection of the works.

From January 2nd to 31st 2024, all information will be given to the jury in order to make a second and third pre-selection via image. The result of these evaluations via image will not be conclusive, it is necessary to send the work to be eligible for Selection, Honorable Mentions and Awards.

5.4 Preselection

All those shortlisted will receive an email with the jury's assessment and with detailed instructions regarding shipping, type of packaging and conditions of participation. Only the shortlisted artists will proceed to ship the work.

5.5 Shipping

The shipping of the work will be carried out to Zaragoza - Spain, until February 29nd 2024 (deadline). The artist is responsible for the cost of shipping and return.

5.6 Selection

Once the works have been received and the admission period is closed, they will be subject to various selection phases in order to verify that they meet all the requirements established in these rules

At the beginning of March 2024, the Jury's decision will be communicated to the awarded artists as well as to those selected.

Likewise, the jury may grant as many Honorable Mentions as it deems appropriate.

Between June and September 2024, the exhibition, presentation of the catalogue and award ceremony will be held at the MEAM Museum in Barcelona (date to be determined). Galería Artelibre may organize exhibitions in other cities, the artists being duly informed of such circumstances.

Galería Artelibre will dispose of the selected paintings for a period of one year, from the end of the registration until the end of the new call. This period will be used for the holding of exhibitions, so no paintings can be claimed for their return by the selected artists.

For these exhibitions, Galería Artelibre holds the right to make a selection of paintings if, due to space limitations, not all selected paintings can be housed in one or more of the exhibition rooms.

6.- The Jury

The jury is independent and made up of professionals from the art world. The jury's decision will be final.

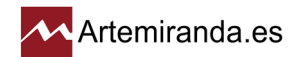

7.- Awards

The first prize of €10,000 is bestowed by the 'Fundación de las artes y los artistas'.

A special prize for drawing is granted in the amount of € 4,000, bestowed by the 'Fundación de las artes y los artistas'.

The BAA (Barcelona Academy of Art) donates 2 workshops of one week duration each. (More information on pages 3-4).

ARTEMIRANDA (www.artemiranda.es) grants one prize of €1,000 for the acquisition of art material.

The 'Special Portrait Award' of €500 is bestowed by Galería artelibre

Diploma of Honour Young Talent (under 25 years of age).

Diploma of Honour Digital Painting portrait.

Diploma of Honour Surrealist - Fantastic Portrait.

The payments of the prizes will be subject to the fiscal regulations imposed by the Law, with the applicable deductions being made. (Prices including VAT and personal income tax withholding)

8.- Copyright

The winning works will become the property of the MEAM and the Fundación de las Artes y los Artistas, which, having their exclusive use, will acquire the rights of exhibition and photographic reproduction of the same. All participating artists will assign the rights of reproduction, printing, information, etc. for the edition of catalogs, advertising, information on social networks, etc., always in the general context of this contest.

Galería Artelibre will not market those photographs in a context that is not within this contest without the artist's prior authorization.

Those artists who are part of associations and / or have registered their works' reproduction rights, must inform Galería Artelibre of such circumstances and bear the expenses that derive from the corresponding rights.

9.-

The organizer of the contest will ensure to take care of the received works, but declines all responsibility for loss, damage or theft, as well as any incident that may occur during their transport, reception, custody, exhibition or return. Any insurance taken out will

be paid by the participant.

10.- Special Drawing Prize

The purpose of the award is to promote and publicize figurative drawing in the portrait mode. All participating drawings will be part of the ModPortrait Special Drawing Contest.

They are subject to the same general rules of the ModPortrait contest.

All techniques and materials employed in the drawings will be submitted to the discretion of the jury whose decision is final.

11.-

Participation in the contest implies full acceptance and conformity with the provisions of these rules.

12.-

Galería Artelibre reserves the right to take initiatives not reflected in these bases, provided they contribute to the better development of the contest and do not substantially affect the essence of it.
